



Siam Legal International Highlights Thailand Privilege Visa Promotions and Deadlines in 2026

Siam Legal International, an authorized General Sales and Support Agent (GSSA) for the Thailand Privilege Visa, is advising current members and prospective applicants to review a series of promotional deadlines closing between August 14 and September 30, 2026, as Thailand continues to attract growing numbers of foreign nationals seeking structured long-term residency solutions.

Thailand Privilege Card Co., Ltd. has introduced several time-sensitive promotions running through the third quarter of 2026. These include a reduced Next Member rate for existing Platinum, Diamond, and Reserve members wishing to add qualifying family members, an Early Bird Upgrade offer for legacy Thailand Elite Easy Access and Thailand Elite Family Excursion members transitioning to the current tier structure, and an extension of the Bronze Membership entry point for new applicants.

The Thailand Privilege programme is a government-backed long-term residency program operated by Thailand Privilege Card Co., Ltd. under the Ministry of Tourism and Sports. The program offers five

membership tiers ranging from five to twenty or more years, providing members with a multiple-entry Privilege Entry Visa, VIP airport facilitation services, government concierge support, 90-day reporting assistance handled by the Thailand Privilege team, and lifestyle privileges spanning travel, health, and wellness. Membership fees range from 650,000 baht for the five-year Bronze tier through to 5,000,000 baht for the invitation-only twenty-year Reserve tier, with no minimum income requirement for primary applicants. The program currently serves more than 40,000 members from over 50 nationalities worldwide and has contributed more than 50 billion baht in annual economic impact to Thailand over its 23-year history.

Thailand's long-stay landscape has continued to evolve in 2026, with visa policy changes, tighter immigration enforcement, and growing foreign interest in structured multi-year residency options all shaping how foreign nationals plan their time in the country. Rather than planning around individual visa cycles, more foreign residents are seeking arrangements that offer stability, flexibility, and reduced administrative burden across several years. Thailand Privilege addresses this demand by removing the need for visa renewals and repeated border runs while providing a single compliance framework that covers the member's full residency period.

Three separate promotional opportunities are currently available with deadlines approaching in the coming weeks. Together they address existing members wishing to add family members, legacy Thailand Elite members considering an upgrade to the current tier structure, and new applicants evaluating their entry point into the program. Full details of each promotion, including eligibility requirements, pricing, savings, and application deadlines, are covered in depth in Siam Legal's Thailand Privilege promotion guide.

"Thailand Privilege is ultimately about how someone intends to live in Thailand, not simply how long they want to stay," said Rex Baay, Senior Immigration Consultant and Operations Manager at Siam Legal International, who has more than 16 years of Thai immigration experience and over 2,000 successful visa approvals. "For people who spend a significant part of the year here and value convenience, stability, and fewer immigration bureaucratic hurdles, the membership can make sense.
